FOR IMMEDIATE RELEASE: Joint Statement Confirmation of Secretary Deb Haaland 3/16/2021 1:00PM

OSAGE NATION: Yesterday, March 15th, 2021, The United States Senate voted to confirm Congresswoman Deb Haaland as the 54th Secretary of the United States Department of Interior. Haaland, of New Mexico's Laguna Pueblo, is the first Native American to ever serve in the Cabinet of a United States President.

The Oklahoman reported on Jan. 18th, 2021,

In a statement after [President] Biden announced his intent to nominate Haaland, National Congress of American Indians President Fawn Sharp said "all of Indian Country celebrates an incredible and historic milestone. The centuries of invisibility of American Indian and Alaska Native people are fading as our best and brightest emerge into prominent positions of leadership."

We agree.

All of Indian Country celebrates this historic milestone and we would like to congratulate the Honorable Deb Haaland on her confirmation as Secretary of the Department of Interior.

"I see this as an important position, not only as a Cabinet official, but as a Leader for Tribal Nations throughout the United States. Each of us will have business before Secretary Haaland and it will be good to see a Native American woman and sovereignty supporter at the same table" said Congressman Tillman.

"The Interior Department oversees national parks and other public lands and resources, and its responsibilities include regulating oil and gas exploration on federal property. The department includes the Bureau of Indian Affairs, the Bureau of Indian Education and the Bureau of Trust Fund Administration." - Oklahoman, 1/18/21

"Secretary Haaland is supported by so many and I am optimistic about the relationships and experience she takes with her to the Department of Interior. I wish the Secretary nothing but success. I am disappointed, however, that the Osage Nation was not a signatory to a letter from Oklahoma Tribal Leaders urging Oklahoma's Senators to support Haaland's confirmation" said Congressman Potts.

Oklahoma tribal leaders said, "As senators for a state with 39 federally recognized Tribal nations and one of the highest Native populations in the United States, you fully recognize the importance of including Native representation at the highest levels of government. Native voices bring unique perspectives to vital discussions, and more often than not have a deeper understanding of the way federal initiatives impact Tribal citizens and Tribal governments. -Oklahoman, 1/18/21

The letter was signed by Leaders from 26 of Oklahoma's federally recognized tribes:

the Absentee-Shawnee Tribe; the Apache Tribe; the Cherokee Nation; the Cheyenne-Arapaho Tribe; the Chickasaw Nation; the Choctaw Nation; the Citizen Potawatomi Nation; the Delaware Nation; the Eastern Shawnee Tribe; the Fort Sill Apache Tribe; the Iowa Tribe; the Kaw Nation; the Kickapoo Tribe; the Kiowa Tribe; the Miami Tribe; the Muscogee (Creek) Nation; the Ottawa Tribe; the Pawnee Nation; the Ponca Tribe of Indians; the Peoria Tribe; the Quapaw Tribe; the Sac and Fox Nation; the Seneca-Cayuga Nation; the Shawnee Tribe; the Wichita and Affiliate Tribes; and the Wyandotte Nation.

We join many in Indian Country today in celebrating Secretary Haaland.

We hope that the Department of Interior, under her leadership, is able to move quickly on matters of importance to the Osage Nation and others. We are confident in our belief that her perspective and understanding will contribute to a period of mutual growth and better representation on issues relating to American Indians.

Secretary Haaland commented in response to her nomination, "A voice like mine has never been a Cabinet secretary or at the head of the Department of Interior." Since March 3, 1849, 172 years, the Secretary's office has never been occupied by a Native American. "Not only is this confirmation welcome, it's about time" said Congressman Potts.

Congratulations Secretary Deb Haaland.

sustainability matters. Without question, Rep. Haaland will be an Interior Secretary for all of America because she shares our common bond: a love of our land and waters and a deep desire to protect them for generations to come.
